
Dear President Judge Emerita Leavitt:

We represent Defendant Paul Lorentz in the above-captioned matter and are writing in connection with the upcoming oral argument on Defendants' remaining preliminary objections to the Amended Complaint, which is scheduled to take place on April 14, 2023, at 10:00 a.m. in the Pennsylvania Judicial Center.

Counsel for the parties have conferred with one another, and in the event that the Court does not have a proposed format in mind, the parties respectfully request that the Court first hear oral argument on Defendant Protiviti Inc.'s remaining preliminary objections, followed by oral argument on Defendant Barry Staldine's remaining preliminary objections, then oral argument on Defendant Brian Wegner's remaining preliminary objections, and concluding with oral argument on Defendant Lorentz's remaining preliminary objections. Also, cognizant that counsel for the Rehabilitator is being tasked with responding to four sets of preliminary objections, the parties are amenable to counsel for the Rehabilitator presenting oral argument—and any rebuttal taking place—before proceeding to the next Defendant's remaining preliminary objections. The parties believe that this format will streamline oral argument and assist the Court in its disposition of the pending preliminary objections.
